

Investment Update for the Generate KiwiSaver Scheme: Stepping Stones 0-35 years old investment option

31 December 2019

This investment update was first made publicly available on 13 February 2020.

What is the purpose of this update?

This document tells you how the Stepping Stones 0 - 35 years old investment option has performed and what fees were charged. The document will help you to compare the investment option with other investment options and funds. Generate Investment Management Ltd prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this investment option

The objective of the Stepping Stones 0 - 35 years old investment option is to provide a growth investment return over the long-term through investment in a portfolio of actively managed cash, fixed interest, property (including aged care) and infrastructure assets¹, Australasian equities and international equities². The investment option has a medium to high level of volatility.

What are the risks of investing?

Risk indicator for Stepping Stones 0 - 35 years old investment option:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the investment option's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way. Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

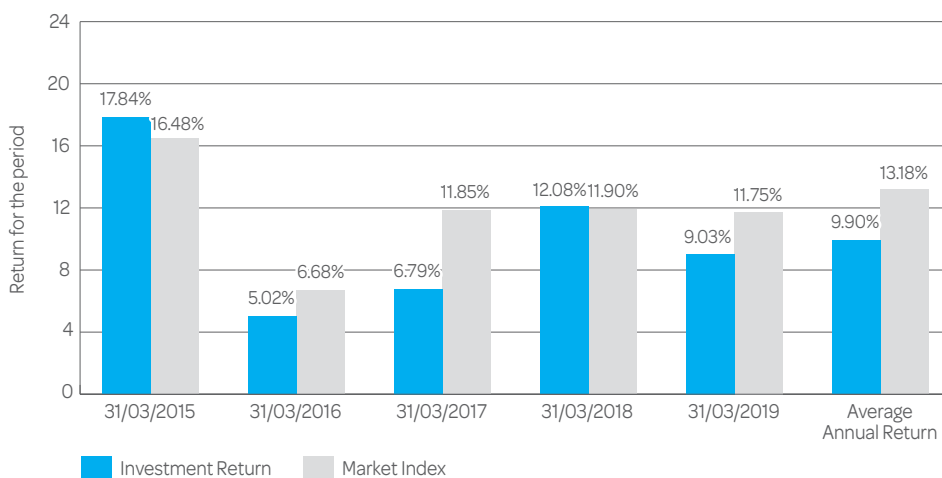
How has the investment option performed?

The market index return reflects a composite of benchmark index returns, weighted for the investment option's target asset allocation, being the investment option's relevant benchmark since inception. All of the share market benchmark indices used include dividends but do not include imputation credits.

Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the investment option started. The last bar shows the average annual return since the investment option started, up to 31 December 2019.

Important: This does not tell you how the investment option will perform in the future. Returns in this graph are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower. Benchmark returns in the graph are before the deduction of tax.

What fees are investors charged?

Investors in the Stepping Stones 0 - 35 years old investment option are charged fund charges. In the year to 31 March 2019 these were:

A portion of the 'other management and administration charges' relate to management, performance and administration charges from investments in underlying funds. Some of these calculations are based on estimates.

Investors are not currently charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). See the PDS for more information about fees.

Small differences in fees and charges can have a big impact on your investment over the long term.

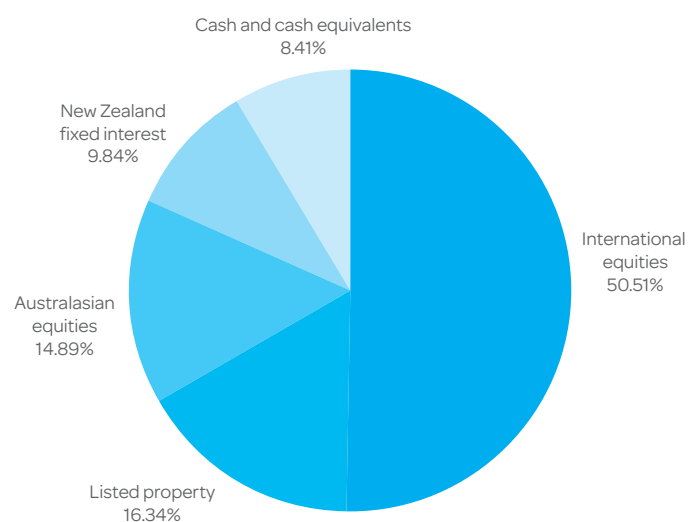
Example of how this applies to an investor

Hannah had \$10,000 in the investment option at the start of the year and did not make any further contributions. At the end of the year, Hannah received a return after fund charges were deducted of \$2,421 (that is 24.21% of her initial \$10,000). Hannah also paid \$36 in other charges. This gives Hannah a total return after tax of \$2,385 for the year.

What does the investment option invest in?

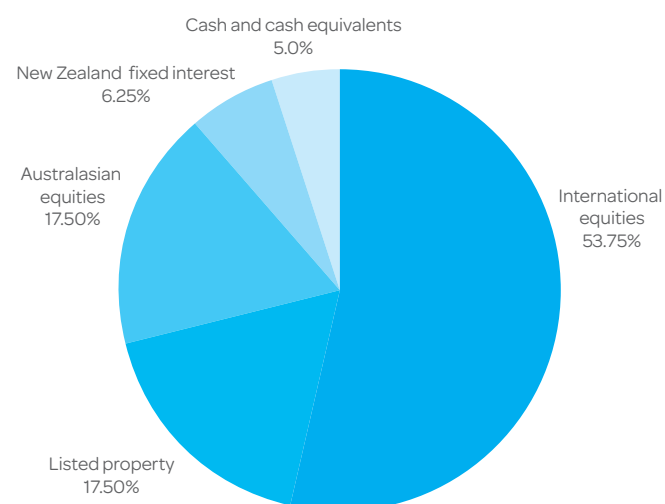
This shows the types of assets that the investment option invests in. ^{1,2,5,6}

The top 10 investments make up 53.52% of the investment option.

The investment option's net foreign currency exposure was 29% of net asset value on the 31 December 2019. At target the investment option's net foreign currency exposure is 27% of net asset value. Notes

1. The Manager takes a broad view of what constitutes infrastructure assets. See the SIPO for further information.
2. International equities are through investments in underlying funds and investments in large capitalisation international stocks.
3. For some of the underlying funds that the investment option invests into estimates were used when deriving annual management fees, performance-based fees and operating costs. The management fee estimate is calculated by either (i) the annual management fees as a percentage of average NAV from the most recent period whereby the information is available or (ii) the sum of the investment option's monthly average investments in the underlying funds concerned, multiplied by the underlying funds' percentage annual management fees. Where otherwise not available the performance fees were calculated using the same performance criteria as that stated by the administrators of the underlying funds and applied to FY19 performance. Performance-based fees are subject to market movements and external manager performance and therefore are likely to differ from period to period. The operating costs for the relevant period for some of the underlying funds were not available. In these instances the operating costs estimate is calculated by either (i) the operating costs as a percentage of average NAV from the most recent period whereby the information is available or (ii) the estimate is the sum of the investment option's monthly average investments in the underlying funds concerned, multiplied by the underlying funds' percentage annual operating costs.
4. Membership fees are the monthly fixed dollar charges for membership in the Generate KiwiSaver Scheme. You will pay only \$3 each month even if you are invested in multiple funds within the Generate KiwiSaver Scheme.
5. 'Cash and cash equivalents' includes the value of foreign exchange hedging derivatives related to the investment option's off-shore investments.
6. Listed property includes investments in aged care companies.
