

## Fund Update for the Generate KiwiSaver Scheme: Conservative Fund

30 June 2020

This fund update was first made publicly available on 28 July 2020.

### What is the purpose of this update?

This document tells you how the Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Generate Investment Management Ltd prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The objective of the Conservative Fund is to provide a conservative investment return through investment in a portfolio of actively managed cash, fixed interest, property (including aged care) and infrastructure assets<sup>1</sup>, Australasian equities and international equities. The fund has a low to medium level of volatility.

### What are the risks of investing?

#### Risk indicator for the Conservative Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way. 
## How has the fund performed?

## Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 June 2020.

Small differences in fees and charges can have a big impact on your investment over the long term.


## Example of how this applies to an investor

Hannah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hannah received a return after fund charges were deducted of \$275 (that is 2.75% of her initial \$10,000). Hannah also paid \$36 in other charges. This gives Hannah a total return after tax of \$239 for the year.

## What does the fund invest in?


This shows the types of assets that the fund invests in.<sup>1,3,4,5</sup>

The fund's net foreign currency exposure was 9% of net asset value on the 30 June 2020. At target the fund's net foreign currency exposure is 6.25% of net asset value.
